Read all instructions!

When using electrical appliances, safety precautions must be followed as described below:

3. **Close supervision is necessary when using by or around children.**
4. Always unplug the product when not in use.
5. **Do not use the product** when obvious damage is noticed to the supply cord or plug. Inspect cord before using.
6. **Do not use the product** if the product has malfunctioned or has been damaged in any manner.
7. **Do not dismantle or puncture the pad for any reason.** This could cause damage and will void the warranty.
8. **Do not cover the product** except with our "fleece cover" because other covers and/or blankets will affect the performance and effectiveness of the product that may cause the product to fail.
9. **Do not use or place on furniture or carpet.** Intended to be placed on hard concrete surface.

**Instruction for use: 120 VAC only**

1. Place the Heated Pet Mat directly on a **hard flat surface** inside a doghouse or kennel.
2. Plug the product directly into a 110/120 volt AC outlet. Allow one hour for the unit to warm to temperature – the LED light will indicate the unit is on. The product may feel slightly warm depending on ambient temperature. Once the animal lies on the mat it will reach its pre-set temperature. Your pet's body temperature will help hold the mats pre-set temperature.
3. Unplug, clean, and store when not in use.
4. Store indoors after winter season. Inspect cord before using. Read all instructions.
5. **Do not use extension cords.**

**Test for proper operation:** This mat will not feel warm to the touch when used in cold climates.

(1) Check the LED indicator light for operation. (2) Place a large heavy object (phone book) on the mat to cover over 1/3 of the surface area. Remove the large object after 30 minutes to test for contained heat underneath the object. If the surface is warm to the touch immediately after removing the large object then the Heated Pet Mat is operating properly. We hope your pet enjoys the warmth during the winter!
