Vendors may be asked to provide documentation establishing such packaging, authorization and authenticity, and must be prepared to produce it upon request. Wizard World does not permit the sale of "bootleg" or unauthorized merchandise at our Shows. By attending our Show, each vendor agrees that any unauthorized or "bootleg" merchandise or material or any merchandise for which the vendor is without documentation proving that the merchandise has been packaged by an approved license holder for the property(s) depicted, may be confiscated at any time, will not be returned, and will not be compensated for, nor will any refunds be made to any vendor removed from the premises for selling unauthorized or "bootleg" merchandise or material, which removal shall be at the sole discretion of Wizard World.

Wizard World works with authorities and rights-holders to act against the sale of "bootleg" merchandise at our Shows. Any vendor caught selling any unauthorized or "bootleg" merchandise or material may additionally be subject to prosecution by local, state or federal authorities, with whom Wizard World cooperates and to whom Wizard World will give access in the event or any complaint against a vendor.

Any vendor in possession of any merchandise or material where the vendor is unsure whether the merchandise may be bootleg or unauthorized should not bring any such merchandise material to the Show or onto the floor. Any vendor intending to sell unauthorized or bootleg material is better advised not to attend a Wizard World show.
