## RED ALERT BULLETIN

At approximately 7:50 am on 10-20-2011 as the juvenile victim was walking north bound on the 3100 block of Cuyler Avenue and approaching the corner of Cuyler Avenue and Park Avenue, the juvenile observed a yellow Ford Mustang with a black top and the word "Mustang" on the bottom of the door. The driver of said vehicle (male white, late 30's or early 40's, 6'00", 150-170 pounds, gray and white mixed goatee, wearing a black White Sox baseball cap) stop/parked on Park Avenue at the corner of Cuyler Avenue. The vehicle driver was holding a camcorder and stated to juvenile: "Come here". The juvenile got scared and ran away from the vehicle and proceeded to call his mother who in turn contacted the Berwyn Police Department. The vehicle fled and was last seen going Westbound on Park Avenue. At this time there is no license plate information or any further information other than what is contained in the attached flyer.

Location of Incident: Park Avenue and Cuyler Ave.

Description of vehicle: Yellow Ford Mustang with a black top and the word "Mustang" on the bottom of the door

Description of driver: Male white, late 30's or early 40's, 6'00", 150-170 pounds, gray and white mixed Goatee, wearing a black White Sox baseball cap

**DESCRIPTION OF OFFENSE:** Above composite likeness is of a male subject described as having a black/white in color White Sox, with a grayish white goatee and wearing a black hoodie. On 10-20-2011 at approximately 0750 hours, as juvenile victim was walking north bound on the 3100 block of Cuyler Avenue and approaching the corner of Cuyler and Park Avenue, juvenile observed a yellow in color Ford Mustang with a black top, stopped/parked on Park Avenue at the corner of Cuyler. Above composite of vehicle driver was holding a camcorder and stated to juvenile "Come here". Victim did not comply and ran S/B on Cuyler at which time vehicle fled last seen going W/B on Park Avenue. Pictured vehicle is similar in appearance but not actual vehicle.
