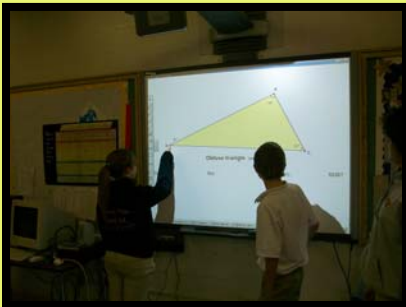

There are several funds to choose from when designating a financial gift. The principal in most of these funds is restricted and only the interest earned is distributed to Burlington Notre Dame.

- **Capital Improvement**
