

Hearth Products Eligible for Tax Credit **Manufacturer's Certificate from England's Stove Works, Inc.**

A federal tax credit on 75 percent efficient biomass heating appliances was reinstated once again. On December 18, 2015, the President signed into law the Consolidated Appropriations Act of 2016 (H.R. 2029). The bill reauthorizes, among other credits, the Sec. 25C tax credit for non-business energy property. Included in this section is the \$300 dollar-for-dollar credit for residential biomass heating equipment. The bill simply moves the expiration date for this credit from December 31, 2014 to December 31, 2016. The credit applies to purchases made in 2015 and 2016. Consumers who made residential biomass heating purchases need to retain for their records a manufacturer's certificate that demonstrates the unit qualifies for Sec. 25C and a receipt (proof of purchase). 
